INTRODUCTION

This Newsletter deals solely with the 2012 ISCA Conference in Greece and Turkey, and consequently this Newsletter serves as the Second Circular of the Conference.

All monetary costs herein are expressed in Euros.

CONFERENCE COST

I am pleased to report that after much work, our Greek and Turkish friends have been able to work up the following budget costs for the two parts of the Conference.

Greek Portion

The cost for the Greek portion of the Conference is estimated to total 405 to 425 Euros per person.

This amount will include:

- Hotel accommodation in Ioannina for three (3) nights (3, 4 + 5 November)
- Hotel accommodation in Drama for one (1) night (6 November). The cost of this
 night is 55 Euros for a single room and 70 Euros for a double room hence the
 majority of the spread between the total price of 405 to 425 Euros.
- All lunches and dinners in Greece
- All bus transportation in Greece (including travel to Istanbul Airport)



It is important to bear in mind that this portion of the Conference includes total bus travel from Ioannina to Istanbul. Consequently, this cost could fluctuate due to fuel prices.

Turkish Portion

The total cost of the Turkish portion of the Conference is estimated to be between 300 and 420 Euros per person. The primary reason for this spread is the hotel rates. For example, the cost per person for single occupancy is 36 Euros per person, whereas this drops to 24 Euros per person for double occupancy.

This amount will include:

- Hotel accommodation in Alanya for three (3) nights (7, 8 + 9 November)
- Hotel accommodation in Antalya for one (1) night (10 November)
- All lunches and dinners in Turkey
- All bus transportation in Turkey

PAYMENT OF CONFERENCE REGISTRATION COSTS

Due to difficulties with bank fees, regulations and currencies we regret to have to inform potential Conference participants that it will **NOT** be possible to pay the Conference registration costs through ISCA's headquarters in Genga, Italy. It is anticipated that the two Conference costs may have to be paid to the organizers of each portion of their Conference in the respective countries. More on this later.

In the meantime, potential Conference participants are advised that no money should be sent to Renata in Genga.

PRELIMINARY REGISTRATION FORM

Despite not being able to handle any monetary matters, Renata will be handling the Preliminary Registration Form for the Conference. The information requested on this Form will greatly help the organizers to fine tune the costs and arrangements.

If you are intending to attend this Conference the Preliminary Registration Form should be returned to Renata (details on form) as soon as possible.
